



## Saving our history

Just about 15 years ago, a small group of people realized, somewhat to its chagrin, that there was no historical society in St. Helena. A committee was formed to develop a mission statement and prepare proper legal documents. By 2002 a nonprofit organization was formed: The St. Helena Historical Society. Because one of the founders happened to be the director of the St. Helena Public Library, a workspace for the society was eked out of the second floor of the library. Volunteers began their work collecting photos and artifacts documenting the early days of St. Helena.

The founding group was enthusiastic and optimistic. They clearly expected that a history center would be established and the collection would be available to the public within just a few years.

Here we are in 2016. The historical society is still in its “temporary” quarters on the second floor of the library. In spite of numerous efforts to find a home for the collection, 14 years later we are still homeless.

### *Hope springs eternal*

During the revision of the 1993 General Plan, a visioning document was developed for the city-owned Adams Street property. Included in that plan is a history/community center. However, the plan stalled and there is little short-term hope that development will happen on the property. As recently as the March 22, 2016, council meeting, the City Council heard from an ad hoc local group promoting a sophisticated, but divisive, plan that will probably just “push forward” the years’ old debate.

In the meantime, the historical society’s collection has grown to include hundreds of photographs and artifacts. We have textiles, Native American tools, furniture, a classic 19th century safe, the bound volumes of the St. Helena Star, a carriage, and 2 trucks, as well as collectables, printed materials, and photographs.

Where are these photos and artifacts? Those that fit are stored in museum quality boxes and files upstairs in the library.

Those that don’t fit in our limited library space are stored in various buildings, storage containers, and garages around


